# Current CESE Issues

What services are rendered by CESE? This is a legitimate question considering that there are such a great variety of professional societies and associations to which one can belong, in a period when subscription fees for publications and memberships are steadily increasing to meet ever mounting costs of mailing, printing, meetings, etc., while at the same time there is a growing hesitancy of governments and other sponsoring agencies to grant subsidies to cover such costs. CESE has been comparably modest in raising its fee in recent years, although we will not be able to avoid a certain increase, since the European Cultural Foundation has stopped its direct financial support. It is, in this situation, an important advantage for us to receive further assistance from the secretarial services offered by the foundation, help for which we are grateful indeed.

Let me return to the starting point of my consideration. The efforts of the Executive Committee and the Secretariat have always been focused on preparing and realizing the biennal Conferences, where we have been mainly dependent on the readness and the activities of voluntary local committees, and, of course on public grants. Moreover, the Secretary-Treasurer takes care of the preparation and publication of our Newsletter which provides information about current «news», in particular about meetings and books of interest for the readers. Finally, high priority is paid to maintaining and intensifying the relationship between CESE and its counterparts, i.e. on the one hand the national and language-bound Comparative Education Societies in and outside Europe, on the other hand the World Council of Comparative Education Societies and other international organizations.

Members, or potential members, may be disheartened by the seemingly meagre offerrings of the CESE. Yet while such a reaction is understandable, I should like to point out the considerable advantages membership in our Society has to offer.

Firstly, the success of all conferences depends on the preparatory work done by the organizers. Participants may be satisfied with the programme or alternatively may be critical of some of its aspects. Their positive remarks and/or criticism are always appreciated; however they must keep in mind the many organizational difficulties that have been surmounted to realize such a convention and to make it workable.

Secondly, CESE feels committed to provide opportunities for comparatists and those wanting to find an approach to Comparative Education to gather and exchange experience and projects. There has recently been an increasing trend in the national and language-bound societies to invite colleagues from abroad which I greatly appreciate. This trend has not, however, lessened the importance of CESE Conferences which continue to offer an exceptional chance to meet many foreign colleagues in an international atmosphere. Moreover, since its start CESE has certainly strongly contributed to encouraging and fostering education among national and language-bound societies. We should go on doing so, and in this context I remember with pleasure my own participation in this year's annual meetings of the Deutsche Sektion in der Bundesrepublik Deutschland der CESE (Regensburg, March), the Association francophone de l'Education Comparée (Sèvres, May) and the British Comparative Education Society (Worcester, September).

Thirdly, the ten CESE Conferences that have so far been held, have been devoted to relevant themes dealing with methodological or topical educational issues. The references to essential socio-political background problems have certainly enriched the range of questions and discussions. In this respect the Conferences have paid their contributions to the progress of our discipline with regard to clarifying our own positions and to identifying the interconnections to related disciplines. Wether, or to which extent individual educationists have received advice and suggestions for specific research projects by conferences is difficult to gauge, but there is good reason to answer in the affirmative, at least judging from the informal talks during the breaks. Such interactions underline the positive function of such meetings

The preparations for our 11th Conference to be held at Würzburg (Federal Republic of Germany) from July 3rd to 8th, 1983, are in progress. The Executive Committee focused its meetings in November 1981 (Frankfurt/Main) and May 1982 (Sèvres, in connection with the AFEC Conference mentioned above) on the organizational and thematic framework of the programme. This activity will be continued at the next meeting to be held in November 1982 in Madrid (in connection with an international educational symposium to be organized by the University of Madrid). In the mean time the Organizing Committee has proceeded with its preparatory activities, the first result of which will become manifest in the PRELI-MINARY PROGRAMME (giving information on the thematic framework as well as on the additional activities and the registration procedure) which is likely to be available by the end of November 1982. All CESEmembers will automatically receive a copy.

I wish to conclude by emphasizing my conviction that it is, after all, the members themselves who decide on the existence and progress of CESE. This is why the Executive Committee will be grateful for any suggestion and support, especially with regard to the forthcoming Würzburg Conference.


#### Dr. Henk Van daele
