# 11th CESE Conference in Würzburg, 3 to 8 July 1983

## Main theme : Education and the Diversity of Cultures : The Contribution of Comparative Education

In recent years, the main theme of this conference has been discussed at numerous meetings; however, there have been different formulations of the topic and of the questions involved and quite different programme content. This diversity of approach is bound to continue, since those interested in this theme are not only educationists, sociologists, linguists and representatives of the Arts and social sciences, but also politicians, educational administrators, teachers and the public at large.

The theme of the 11th CESE Conference is very topical, both academically and politically; but the organizers recognize the risk of repeating or paralleling others' efforts. We therefore see the essential starting-point in the concentration of all contributions on the following question: how the global phenomenon of « multi-culturalism » is mirrored in theoretical and practical approaches to problems arising in international or intercultural comparisons.

The intellectual perspective for presentations and discussions is seen in an interdisciplinary approach and reference to practical experience, subjected to **comparative analysis** as far as possible. **Multidisciplinarity**, in this context, means, firstly, interpreting the concepts of « culture » and « multiculturalism » by drawing on statements from the various disciplines, and, secondly, by analysing specific « cases » and « sectoral » approaches.

**Relevance to practice** underlies our major interest in experiments bearing on possibilities of multicultural education in various socio-political conditions. Within this framework, both macro- and micro-studies are included.

The **European scene** confronts the educationist with a wide diversity of cultures rooted in ethnic, religious and social characteristics, which have determined the history of this continent for centuries. Particular interest is therefore paid to the mutual impact of « national » and « cultural » systems manifesting themselves in different understanding and practices of education in national states seeing themselves hitherto as, in principle, « homogeneous ».

**Conflicts** arising when two different cultures come into contact fall mainly into one of two categories.

1. One traditional form of conflict is seen when minorities of long standing (often the older inhabitants of the region or national territory) confront a dominant culture, claiming to be the only (or the « true ») representative of the national identity.
2. A new form of conflict arises with the arrival of « foreign groups, with distinct ethnic, religious, linguistic and social characteristics. The status of such new residents as permanent immigrants, internal migrants, « guest-workers », or perhaps as refugees, accentuates and differentiates the problems which arise.

Another theme focuses on interrelations between Europe and the other continents.

CESE has never understood itself as a Euro-centered organisation and recognizes that multiculturalism is a worldwide phenomenon. Many « traditional » European problems were exported to non-European regions in colonial times, and the confrontation of « national » and « cultural » patterns burdens the search for identity of many Third World countries, now independent. A major interest in the conference programme is therefore to examine European and non-European multiculturalism, within the framework of North-South relationships, including an historical perspective.

The Conference Programme will be organized around six themes. In broad terms, the thematic interests may be defined as : theoretical analysis, examination of policies and strategies, case studies, especially empirical case studies, in the European context, international relationships, perspectives on emerging sub-cultures.

1. Multiculturalism and multicultural education - a multidisciplinary approach.
2. Multiculturalism and multicultural education : perspectives on policy and alternative strategies.
3. Multiculturalism and multicultural education in Europe : case studies of national education systems and ethnic or cultural minorities.
4. Multiculturalism and multicultural education in Europe : problems concerning the « integration » of immigrants, guest-workers and refugees into the education systems of host countries.

5. Multiculturalism and multicultural education as exemplified in the relationships between European countries and the Third World.
6. Perspectives on and from emerging subcultures (especially youth, the unemployed, the social position of women, etc.).

These six thematic areas will be introduced by invited speakers in **major speeches** and will be developed and discussed in **working groups**. The preparations for the groups will be undertaken by the following colleagues :

Written contributions, which should not exceed 15 pages, A4, double spaced typing, are requested by February 1, 1983. They should be submitted to the coordinator of the relevant working group and can be in English, French or German.

In addition, we request a one page abstract in one of the official languages of the Conference.

As at previous CESE conferences, « optional working groups » may be arranged in addition to the official working groups dealing with the themes outlined above. Suggestions for the optional working groups should be addressed directly to the Conference Secretariat.
