13TH CESE CONFERENCE IN BUDAPEST : 1ST PREPARATIONS

Thanks to the invitation which Dr. Magda Illés, Scientific Secretary of the Section of Comparative Education in the Hungarian Pedagogic Society, extended to the CESE General Assembly at Antwerp (July 1985) on behalf of her Society, our 13th Conference will be held in Hungary at the end of June, 1988. As regards the place, Budapest, the beautiful capital of Hungary, has been chosen by the Hungarian organizers.

On behalf of the CESE Executive Committee I spent three days (January 23 to 26) in Budapest in order to enter into preparatory talks with leading members of the Hungarian Pedagogic Society. I was cordially welcomed by them, in particular by Professor Dr. Marton Horvath, Secretary General of the Society and Dr. Magda Illés. Besides, Dr. Andras Benedek and Dr. Andras Timar (both members of the Central Pedagogic Research Institute) participated in the meetings. I reciprocated the welcome by passing my best regards on behalf of Professor Dr. José Luis Garcia Garrido and the CESE Executive Committee emphasizing our satisfaction at the readiness of the Hungarian Pedagogic Society to organize the 13th CESE conference in Budapest.

In particular I expressed my pleasure at the information that the Minister of Education and Culture of the Hungarian People's Republic had taken over the protectorate over the CESE Conference.

The present members of the Hungarian Pedagogic Society and I myself (on behalf of the CESE Executive Committee), came to an agreement which has laid the ground for the preparatory process to take place in the next two years. The Hungarian Pedagogic Society has formed an Organizing Committee consisting of the following persons:

In order to provide an efficient preparation of the 13th CESE Conference the CESE Executive Committee and the organizing Committee will keep permanent contact and, in particular, intensify the co-operation by arranging two meetings which will be attended by delegates of both Committees. The Hungarian organizers will take care of providing accommodation at three price-levels in order to create good conditions which may hopefully enable all CESE members and many other comparatists to attend the Conference. They will also provide facilities for plenary meetings, meetings of six working groups, interpretation of the plenary meetings (English, French, German, Russian) and secretarial work. It should also be mentioned that a by-programme, consisting of visits and trips during and before/after the Conference will be offered.

The main theme of the 13th Conference will be discussed and formulated by the CESE Executive Committee. Distinct consideration will be given to the proposition which has been submitted by Dr. Magda Illés to the General Assembly at Antwerp:

“The Development of Human Personality under the Impact of Sociological and Value Change (a comparative prospective)”

Readers of the Newsletter are kindly asked to give their comment and proposals to the Executive Committee until October 1986, when the Executive Committee will meet again at Garda on the occasion of our 25th Anniversary.

I have come back from Budapest with the impression that the commitment of the Hungarian Pedagogic Society to organizing our next Congress gives a good outlook. Let us hope that all our expectations may be fulfilled. The Minister of Education and Culture of the Hungarian People's Republic, Dr. Köpeczi has articulated his interest in the Conference which he has underlined by his personally receiving me half an hour for a talk in his office in the afternoon of January 24.

Unter dem Titel «Lehrerbildung in europäischen Ländern» haben Friedrich W. Busch (Universität Oldenburg) und Detlef Glowka (Universität Münster) in deutscher Sprache eine Auswahl von 14 Aufsätzen veröffentlicht, die für die vom 13. - 18. Oktober 1983 in Kolymbari/Kreta durchgeführte Internationale Konferenz über Fragen der Lehrerausbildung vorgelegt wurden. Die Konferenz fand unter der Schirmherrschaft des griechischen Erziehungsministers statt und wurde getragen vom Council of Europe (Strasburg), der Vereinigung für Lehrerbildung in Europa/ATEE (Brüssel) und der Abteilung für pädagogische Studien der Universität Kreta (Chania).

Für die deutsche Auswahl waren zwei Gesichtspunkte bestimmend: die auf der Konferenz vertretenen Länder sollten möglichst vollständig durch einen Überblick vermittelnden Beitrag repräsentiert sein, und die in einem Land eingeleiteten Innovationen sowie die damit gewonnenen Erfahrungen sollten zu Wort kommen. 

Higher Education Cooperation in the European Community

A conference on Higher Education Cooperation in the European Community, organised by the Office for Cooperation in Education (OCE) on behalf of the Commission, was held in Brussels from 27 to 29 November 1985. The European Unit of Eurydice exhibited at the conference and distributed over 500 information dossiers to participants. These dossiers contained information relating to the European Unit of Eurydice and Community policy in the field of higher education. The European Unit of Eurydice gave documentary support to the drawing up of the two proposals for Council decisions concerning COMETT (Community Action Programme in Education and Training for Technology), which was approved by the Ministers of Social Affairs and of Education in the Council of December in Brussels (subject to a query by the F.R. of Germany on financing), and ERASMUS (European Action Scheme for the Mobility of University Students).

European Institute of Education and Social Policy

The European Institute of Education and Social Policy was established in 1975 by the European Cultural Foundation in cooperation with the Commission of the European Communities and the International Council for Educational Development, New York. It is an integral part of the Foundation but has full academic autonomy. The main focus of the Institute's work lies in comparative studies and other activities relating to specific policy issues in post-compulsory and higher education, especially with regard to employment, regional development and new information technology, forging a link between educational research and policy-makers, and promoting closer cooperation at the European level in this field.

10th Anniversary of the Institute

At the end of 1985 the Institute completed the 10th year of its existence and activities. Several events marked this anniversary.

20th Meeting of the Eurydice Steering Group

The 20th meeting of the Eurydice Steering Group was held in Brussels on 13 November 1985 under the chairmanship of the Commission of the European Communities.

Questions discussed included national information dossiers, the review of the operation of the Eurydice network, education policy developments at Community and national level, and the EUDISED multilingual Thesaurus.
